Diogo earned a 306 scale score on the FAST PM2 Math assessment, which is an Achievement Level 2 and at the 65th percentile. On the FAST PM 2 ELA assessment, he earned a 318 scale score, which is at Achievement Level 3, and at the 68th percentile. On the NWEA Science Assessment, he earned a scale score of 214, which is at the 90th percentile. On last year's FSA Math, he earned a scale score of 331, which is at the achievement level 5. On the last year's FSA ELA, he earned a scale score of 320 which is at the Achievement Level 4. And on his latest NSGRA assessment, he was reading at a level Z.

### V. Notes

Meeting was held today (4/20/23) to review the results of Diogo's psycho-educational evaluation, determine if he is eligible for supports and services through the Gifted program, and develop an EP, if appropriate. Members of the committee were introduced.

Karly Mendoza, School Psychologist Intern, shared the results of the evaluation with the committee. Diogo was referred for an evaluation following the completion of an intellectual screener. His teachers completed checklists regarding characteristics of gifted students. Diogo received a level 5 on the Math FS and a level 4 on the Reading FSA. An intelligence test was administered to assist in determining eligibility for gifted services. Diogo is a 4th grade student t Pleasant Hill Elementary School. He enrolled at this school in Kindergarten on 8/13/18. He was born in Canal Zone in Panama and Spanish was his first language. He was exited from the ESOL program in 5/28/21. On the CogNAT Gifted Screener, he earned a std. score of 88, which is in the 23rd percentile. He earned 135 points out of 160 points on the teacher checklists ratings for Potentially Gifted students. Diogo separated from his class to go to the testing room very easily and rapport was quickly established. He shared that he wants to be an engineer when he grows up. He was attentive and focused and persisted when items became more difficult.

Diogo was administered the Reynolds Intellectual Scales-2nd ed. His Verbal Intelligence Index was a 114 std. score, which is at the 82nd percentile, and considered to be in the Above Average range. On the Nonverbal Intelligence Index, he scored a 110 std. score, which is at the 75th percentile and considered to be in the Above Average range. His Composite Intelligence Index was a 114 std. score. His relative strength on this test was in Verbal Comprehension.

Mom shared that they are returning to Panama at the end of the school year. We explained that if they return to the area, then, he would continue to be eligible for the Gifted program and services. They could provide the information to the school in Panama and if they have advanced classes there, they could use the information to help determine him eligible for those services. She shared that he was very advanced even in Pre-K or Kindergarten.

The committee reviewed the eligibility criteria for the Gifted program. In reviewing eligibility criteria, the committee determined that Diogo is eligible for services under Plan B, based on the standard error of measurement.

Mrs. Gonzalez shared the draft EP and goals and all are in agreement that they will meet Diogo's educational needs at this time.

All paperwork was signed, with copies being provided to the parent, along with procedural safeguards. No one on the committee prohibited the parent from inviting a person of their choice to the meeting.
